Federalist Paper 39, Madison, p. 245, Mentor Pub. Ed.;

* "The local or municipal authorities form DISTINCT and INDEPENDENT PORTIONS of the SUPREMACY, NO MORE SUBJECT, within their respective spheres, to the GENERAL AUTHORITY than the general authority is subject to them, within its own sphere." Home Rule : Self Government.

Federalist Paper 51, Madison, p. 323, Mentor Pub. Ed.;

* "In the COMPOUND REPUBLIC of AMERICA, the POWER SURRENDERED by the People is first divided between TWO DISTINCT GOVERNMENTS, and then the portion allotted to each subdivided among DISTINCT and SEPARATE DEPARTMENTS. HENCE A DOUBLE SECURITY ARISES TO THE RIGHTS OF THE PEOPLE. The DIFFERENT GOVERNMENTS will CONTROL EACH OTHER, at the same time that each will be CONTROLLED BY ITSELF." (Self Governed)

Federalist Paper 15, Hamilton, p. 108, Mentor Pub. Ed.;

* "Except as to the rule of apportionment, the United States have an indefinite discretion to make REQUISITIONS for MEN and MONEY; but they HAVE NO AUTHORITY to raise either by REGULATIONS extending to THE INDIVIDUAL CITIZENS OF AMERICA." (PROTECTED SELF DETERMINATION)

Federalist Paper 15, Hamilton, p. 110, Mentor Pub. Ed.;

"Government implies the power of making laws. It is essential to the idea of a law that it be attended with a sanction; or, in other words, a penalty or punishment for disobedience. If there be no penalty annexed to disobedience, the resolutions or commands which pretend to be laws will, in fact, amount to nothing more than advice or recommendation." (this means also that without "police power jurisdiction" no "law" can be enforced which originates in another unit of Government)

Federalist Paper 10, Madison, p. 78, Mentor Pub. Ed.;

"The diversity in the faculties of (men), FROM WHICH THE RIGHTS OF PROPERTY ORIGINATE, is not less an insuperable obstacle to a uniformity of interests. THE PROTECTION OF THESE FACULTIES IS THE FIRST OBJECT OF GOVERNMENT." (PROTECTED INDIVIDUAL AND PROPERTY)

Federalist Paper 33, Hamilton, p. 203-4, Mentor Pub. Ed.;

"THE PROPRIETY OF A LAW, IN A CONSTITUTIONAL LIGHT, MUST ALWAYS BE DETERMINED BY THE NATURE OF THE POWERS UPON WHICH IT IS FOUNDED."
